## **PROCEDURE FOR ONLINE COUNSELING 2025**

The **Online Counselling Portal** <https://fddi.qualcampus.com> has been set up by the Footwear Design & Development Institute to manage and regulate the joint seat allocation for admissions to 12 campuses of the Institute for the academic year 2025-26. Admission to all the academic programs offered by FDDI will be made through a single platform.

### **Filling-in of choices:**

Candidates may fill-in their choices of Courses and campuses in decreasing order of their preference (Most preferred comes First). For Under Graduate & Post Graduate Programmes it is mandatory for all the candidates to fill in at least-

- **12** choices in case of Only B.Des. Programmes
- **04** choices in case of Only BBA Programme.
- **12 +4** choices in case of Both B.Des (12) & BBA (4)
- **10** choices in case of Post Graduate Programme.

### **Submission of Counseling fee:**

**General Category:** Candidates are required to submit fee of Rs. 25,000/- (Rs 10,000 Registration Fee + Rs. 15,000 advance semester fee) to participate for FDDI Online Counseling 2025. Later, this Rs. 25000/- fee will be adjusted against the first semester balance fee.

The Registration fee Rs 10,000 will be non-refundable. However, if a candidate is not allotted a seat of his/her choice then the amount of Rs 15,000/- Advance semester Fee will be refunded to their source of Payment. (As per the FDDI withdrawal policy).

**SC/ST/OBC (Non-Creamy)/EWS/PWD category:** Candidates are required to submit fee of Rs. 10,000/- (Rs. 5,000/- Registration Fee + Rs. 5,000/- refundable security deposit) to participate for FDDI Online Counseling 2025. Later, this Rs. 10,000/- fee will be adjusted against the first semester balance fee.

The Registration fee Rs 5,000 will be non-refundable. However, if a candidate is not allotted a seat of his/her choice then the amount of Rs 5,000/- security deposit Fee will be refunded to their source of Payment. (As per the FDDI withdrawal policy).

Those candidates who are not paying the counselling fee will be out of the admission process.

**Important note:** Registration fee is non-refundable, however, if a candidate is not allotted a seat of his/her choice then the amount of Rs. 15,000/- Advance Fee for General Category & Rs. 5,000/- for SC/ST/OBC (Non Creamy)/EWS/PWD category candidates will be refunded to their source of Payment. **(Please Refer the FDDI withdrawal policy on FDDI official website).**

**All refund requests should be submitted to admission department.**

### **Allotment of Courses and Campus**

The allotment of seats will be displayed on the Counseling portal. The seats available in each Course/Campus under each admission category will be allotted to candidates in order of their ranks and as per their preferences subject to availability. Candidates can either “accept the seat” or “accept with upgrade” to participate in next round of seat allotment.

**Candidates allotted seat as per their First preference is required to accept the allotted seat and will be required to pay the 1<sup>st</sup> semester balance fee by the provisional date for confirmation of his/her admission.**

For subsequent round of seat allotment there is no fresh registration of candidates and choice submission for further round of counseling. The choice submitted during the main counseling session (prior to the first-round allotment) will be taken into account for further rounds of allotment.

### Who are eligible for subsequent Round of allotment?

Candidates eligible for seat allotment in subsequent round would be from one of the following groups:

**Group-I:** Registered candidates who did not get any seat allotment.

**Group-II:** Registered candidates, whose 1st round of allotted Seat Cancelled due to missing document/s, who have secured seat under reserved quota, due to change of Category from reserved to Unreserved or PH status, but are still eligible in the next round of seat allotment, with changed Category, subject to fulfillment of eligibility conditions.

**Group-III:** Candidates who have submitted willingness for second round up-gradation as “Accept with upgrade” and paid the 1<sup>st</sup> semester balance fee according to 1<sup>st</sup> allotment.

### Who are not eligible for 2nd Round of allotment?

- Candidates Allotted seat as per their First Choice in 1st round.
- Reported in 1<sup>st</sup> Counseling but didn't submit the 1<sup>st</sup> semester balance fee.
- Candidates who fixed their choice and marked “Accepted” with the seat allotted in the 1<sup>st</sup> round and declined for “Accept with upgrade” option.

### 1<sup>st</sup> Semester Balance Fee Payment

Candidates allotted seat in a particular course and campus in order of their merit & choice will be required to pay 1<sup>st</sup> semester balance fee by the stipulated date as prescribed by the Institute. The process to pay the 1<sup>st</sup> semester balance fee is provided in the Counseling portal. Candidates need to pay the fee within the defined time-frame. After successful fee payment, candidates' will be granted Provisional admission.
