Under this renewed collaboration, FDDI is set to encompass the remaining eight campuses namely, Jodhpur, Patna, Kolkata, Chhindwara, Guna, Chandigarh, Ankleshwar and Hyderabad furthering the institute's commitment to inclusive education.

The initial MoU, signed on March 16, 2023, focused on four FDDI campuses located in Noida, Furstagunj, Rohtak, and Chennai.



On behalf of FDDI, Mr. Arun Kumar Sinha, IAS, Managing Director (MD), FDDI signed the MoU, whereas, on behalf of Canara Bank, Mr. Bhavendra Kumar, Chief General Manager signed the MoU during which the senior officers from both the sides were present.

The primary objective of this extended MoU remains the same, i.e. to provide collateral-free education loans to FDDI students at a competitive interest rate. Canara Bank continues to be the lending institution, offering valuable financial support of up to Rs. 30 lakhs to eligible students across the FDDI campuses.

The term of this renewed MoU will span five (5) years, commencing from the date of execution. Importantly, the terms and conditions of the education loan remain highly favorable for students. Notably, there are no processing charges or upfront fees associated with the loan application process. Furthermore, students will benefit from the convenience of having their loan applications processed by the designated branch, without the need to consider their permanent residence or their parents' place of work. The application process simply requires students to submit duly completed and signed loan applications, along with the necessary supporting documentation, streamlining the process to secure the necessary funds for their higher education.

This initiative represents a remarkable commitment to alleviating the financial burdens that often deter aspiring students from pursuing their academic aspirations. By removing these financial constraints, FDDI and Canara Bank are working together to ensure that quality education remains accessible to all, regardless of their economic background. This collaborative effort is poised to not only empower students but also catalyze growth and enhancement within the Indian education sector.

Furthermore, this renewed partnership aligns seamlessly with several of the Hon'ble Prime Minister's key initiatives, including 'Vocal for Local,' 'Make in India,' 'Aatmanirbhar Bharat,' 'Skill India,' and 'Start-up India.' Under the Convergence of Institutes, MoU signed between FDDI, Patna & NIFT, Patna

Under the Convergence of Institutes, a Memorandum of Understanding (MoU) on 'Institutional Collaboration' was signed between Footwear Design & Development Institute (FDDI), Patna and National Institute of Fashion Technology (NIFT), Patna on 9th September 2023 for institutional collaboration in education, research outreach programmes and faculty exchange.

The primary objective of this collaboration is to promote collective and collative teaching and research collaboration involving faculty members and students at FDDI Patna and at NIFT Patna to ensure teaching and research of highest standard, carry out joint academic and research programmes, as well as collaborative research projects.

The convergence of the five institutes under the Ministry of Textiles and Commerce and Industry was initiated in the month of November 2022. The five institutes are FDDI, IIFT, IIP, NID and NIFT.

On behalf of FDDI, Mr. Sanjeev Kumar Mishra, Center Incharge, FDDI-Patna campus and Prof. Colonel Rahul Sharma, Director, NIFT-Patna signed the MoU which is based on the strength of two premier Institutes of the country.



The signing ceremony took place at the FDDI-Patna campus wherein Mr. Pankaj Kumar Sinha, Secretary FDDI and other prominent figures from both the institutions were present.

Shipment that is "CUT – TO – PACK" including sampling, costing, knitting, cutting, production planning, sourcing of raw material and production pattern making, fabric cutting, printing, embroidery, sewing, thread trimming, washing, ironing, store department, folding and packing are the production functions.

As per the buyer requirements the development stages of samples are named as Proto sample, Fit sample, Size set sample, Sales man sample, production sample, Top of production (TOP) sample and shipment sample were explained in detail. They were also briefed about CAD/CAM which enables the designer, pattern maker, marker and grader to do their jobs precisely and effectively.

It was a beneficial visit for the students as they interacted with the departmental heads and gained practical knowledge about garment production right from the fabric to finished product and steps of quality checks.
