All the **Final Year students** of all campuses are hereby informed that in view of placement requirements, the **Re-Do Examination for Final Year students** shall be conducted **earlier than the regular schedule**.

All the fee defaulters are required to submit the Semester Fee of Current Semester at the earliest to be eligible for Re-do Examination.

The Re-Do Examination for Final Year students shall commence from **16 February 2026**, instead of being held after declaration of results of even semester as per the Academic Calendar.

The **Date Sheet of the Re-Do Examination (Final Year)** along with the **Re-Do Examination Form** has been uploaded on the FDDI website, i.e. **www.fddiindia.com**.

All concerned students are required to check their results in the ERP and fill out the Re-Do Examination Form. The duly filled form must be verified by the respective Campus SA&E Department.

After verification by SA&E, students are required to submit the applicable Re-Do Examination fee to the bank account provided by the Accounts Department of their respective campus on or before **12 February 2026**.

After submission of the Re-Do Examination Fee, concerned students are required to submit their duly filled Re-Do Examination form along with Re-Do fee receipt with Student Affairs & Examination Department at their respective campus and collect the Hard Copy of the Admit Card.
